



## **Additional Terms and Conditions for TDC Business Broadband:**

**TDC BizBase**

**TDC MultiBase**

**TDC Extrabase**

**TDC MyBase**

June 2019

(This is a translation from Danish. In the event of a conflict between the Danish version and the English version, the Danish version prevails).

### **1. The Supplementary Agreement**

For subscription agreements on TDC Business Broadband, including TDC BizBase, TDC MultiBase, TDC ExtraBase and TDC MyBase, the following terms and conditions apply in addition to the Subscription Terms for TDC Broadband and the Subscription Terms for TDC's Data Services and Data Networks. In the event of a conflict between the terms, these separate Terms and Conditions for TDC Business Broadband will prevail.

A TDC Business Broadband agreement comprises the following:

- Connection from the installation site to TDC's IP network either via TDC's fibre network or via TDC's xDSL service with the speed agreed with the customer based on the possibilities in the area in which the installation site is located. The agreed speed is specified in TDC's order confirmation, which also states whether the connection is via TDC's fibre network or via TDC's xDSL service. If a MyBase agreement has been entered into, the connection cannot be made via TDC's fibre network.
- Access to TDC's Internet service, see the Subscription Terms for TDC Broadband.
- Access to Redundancy Mobile, see the separate Additional Terms and Conditions for this.  
Redundancy Mobile gives the customer Internet access via TDC's mobile data services if the customer's primary connection to TDC's IP network is out of operation. In addition, the customer is entitled to purchase, as an add-on and against extra payment, Redundancy Mobile Plus, which gives the customer Internet access and access to the customer's VPN MPLS network via TDC's mobile data services if the customer's primary connection to TDC's IP network is out of operation.
- Possibility of using TDC Business Broadband with the functions and features attached at any given time to the subscription type chosen.

The contents of the TDC Business Broadband agreement also depend on which of the following subscription types the customer has chosen:

- TDC BizBase, TDC BizBase M, TDC BizBase L, TDC BizBase XL or TDC BizBase XXXL
- TDC MultiBase, TDC MultiBase M, TDC MultiBase L, TDC MultiBase XL or TDC MultiBase XXXL
- TDC ExtraBase, TDC ExtraBase M, TDC ExtraBase L, TDC ExtraBase XL or TDC ExtraBase XXXL.
- TDC MyBase

The contents of the TDC Business Broadband agreement may, depending on the subscription type chosen, include the following:

- Establishment of a virtual private data network within TDC's IP network (TDC VPN MPLS), see the Subscription Terms for TDC's Data Services and Data Networks.
- Secure connections to the customer's virtual private data network
- Router, including the possibility of a wireless router
- Security products, including firewall, antivirus software and anti-spyware
- Service agreement for networks, services and routers
- Support and hotline

The detailed contents of the TDC Business Broadband agreement, including TDC BizBase, TDC MultiBase, TDC ExtraBase and TDC MyBase, are described in the relevant product sheets, and are also stated in TDC's order confirmation to the customer.

Information about the prices in force at any given time for TDC Business Broadband can be obtained by contacting TDC.

## **2. Minimum subscription period – agreements on TDC Business Broadband with fibre**

If the connection from the installation site to TDC's IP network is established via TDC's fibre network, the TDC Business Broadband agreement (TDC BizBase with fibre, TDC MultiBase with fibre or TDC ExtraBase with fibre) is non-terminable for 21 months after delivery. The customer may subsequently terminate the agreement at minimum three months' notice. A total minimum subscription period of 24 months consequently applies to a TDC Business Broadband agreement.

Clause 8 of the Terms and Conditions for TDC's Data Services and Data Networks and Clause 17 of TDC's General Terms and Conditions also apply.

## **3. YouSee Music – agreements on TDC Business Broadband with xDSL**

If the connection from the installation site to TDC's IP network is established via TDC's xDSL service, and if the customer is a residential customer or if

there is a permanent employment relationship between the customer and the registered user (home workstation), YouSee Music may be included in the subscription to TDC Business Broadband in the subscription types TDC Biz-Base with xDSL or TDC MyBase with xDSL.

If the customer is entitled to use YouSee Music, the customer may opt out of YouSee Music with a resulting reduction of the subscription charge.

The detailed terms and conditions for YouSee Music are stated in separate Additional Terms and Conditions for YouSee Music.

The customer must be aware that special VAT and tax rules may apply to the use of YouSee Music.
